

# **Assisted Transport Policy**For Adult Social Work Services

June 2023





#### 1. Policy Statement

The ability of clients to access health and social care by appropriate means of transport is an essential component of their treatment or care pathway. It is recognised that because of the size of Aberdeenshire and the limitations of the transport network there can be challenges in delivering services and enabling service users to access services.

This policy provides a consistent approach to transport for social work services which is aligned with the strategic aims and outcomes of the Health and Social Care Partnership and supports the objectives of the Grampian Health and Transport Action Plan.

#### 2. Scope of policy

This policy applies to people who:

- Are aged over 18 and not in full time education,
- Have an assessed need to access social work services,
- Are ordinarily resident in Aberdeenshire.

#### 3. Principles

#### Health

- The Health and Social Care Partnership wants to encourage people to be physically active. Walking even short distances can help people to feel better mentally and physically.
- Any decisions regarding procurement of transport should consider the public health impacts of the transport system.

#### Equality

- Transport will be provided where it is not possible for the person to use public transport or travel by other independent means. Practitioners will use their professional knowledge and case experience in determining an individual's eligibility for support with transport.
- People who are unable to access public transport without assistance should be provided with support to travel where possible so that they are not disadvantaged.

#### Promoting Independence

- Any transport that is arranged must support the person to be as independent as possible.
- Assistance with transport must support the person to make the best use of their abilities and local resources.
- Any service that is arranged for the service user should be as local as possible. Transport should not be provided to take the person to a resource further away if there is a reasonable alternative closer to where the person lives.

#### Affordability

- Where people are in receipt of a financial mobility benefit this should be considered to contribute towards transport costs to access services. Any consideration to use mobility benefit to fund transport would be considered as part of the financial assessment.
- If the person owns a Motability vehicle, this should be available to transport the service user to access services.
- An assessment of need and subsequent package of support should take into account the travel and transport arrangements that can be made and the affordability of any transport. This should happen regardless of the Self-Directed Support option that is chosen.
- Any request for help with transport will be underpinned by a comprehensive assessment
  of need and will take into account the efficient and sustainable use of public resources.
  The support plan will detail any requirement for transport and the specific eligibility criteria
  that apply.

#### Eligibility

- Assistance with travel or transport should only be considered after all the other options have been explored. For a request to be considered, all the following (1-5) must apply:
  - 1. The person is attending a resource or facility for which there is no suitable more local alternative.
  - 2. The distance is too great for the person to walk independently or with help.
  - 3. The person does not have their own transport.
  - 4. There is no public transport available, or the person cannot use public transport or has difficulty accessing public transport unassisted.
  - 5. There is no assistance with transport available from family or friends.

Or

- 1. The person is subject to conditions laid down in the Mental Health Care and Treatment (Scotland) Act 2003 and is therefore entitled to assistance with travel.
- Financial support with transport will only be given where a financial assessment has been carried out and the cost of transport would cause financial hardship.

#### **Escorts**

• Where a person is eligible to be accompanied by an escort to ensure their personal safety, this will be included in their Self-Directed Support plan.
