Your information is being collected to use for the following purposes:

- To support the assessment of a young person’s needs when they stop being Looked After
- To help inform how the Throughcare and Aftercare Service can work with the young person to help them move on to the next stage in their life until they are living independently
- To inform Throughcare and Aftercare Service Pathway Reviews for individual young persons, and to assist self-evaluation and improvements.
- To ensure financial payments can be made to eligible young people.

A young person can choose not to take up these services, but the Local Authority must regularly ensure they have attempted to offer and provide such services where needed, and will contact eligible young people at regular intervals. If relevant information is not provided by the young person, we will be unable to fulfil these responsibilities.
