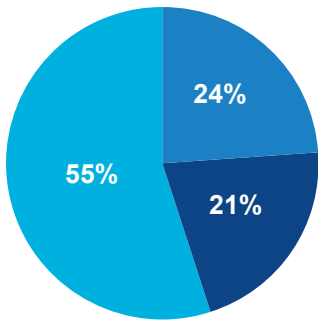

Council Tax will be increase by 3% in Aberdeenshire for 2022/23
