Your information is being collected to use for the following purposes:

- To provide day-to-day management, maintenance, enforcing parking regulations, administering parking charges, issuing car parking permits, dealing with unauthorised use of car parks and general enquiries.
- Car Park Operatives patrol off street and on street sites and use handheld camera devices to enforce parking prohibitions, terms, and conditions. Where these have not been complied with, your personal data may be collected, processed, shared, and retained to carry out the performance of a public task and fulfil our legal obligations. Personal data is collected to service an Excess Charge Notice or Penalty Charge Notice and enforce any parking terms and conditions or Pavement Parking Prohibitions. When a contravention has occurred, your personal data may be collected, processed, shared, and retained in order to carry out the performance of a public task and fulfil our legal obligations in the following ways:
 - To request details of the registered keeper of the vehicle from the DVLA to pursue an Excess Charge Notice or Penalty Charge Notice.
 - o Shared with authorised third parties for appeals, enforcement & charge recovery.
 - Shared with the police or security organisations to prevent or detect crime.
