#### 1 Welcome & Apologies

1.1 The Chair welcomed those present and apologies were noted as above.

#### 2 Declarations of Interest (DOI)

- 2.2 Gerald Banks made a declaration of interest regarding application RCCF013 Strichen Community Park Access Improvements & EC Facility. Gerald Banks will leave the meeting during discussions on this project.

- 5 Paper 1 Project Assessment Report
- 5.1 Jamie Wilkinson reported back to the LAG on the Paper 1.
- 5.2 The total request for funds from applications is £507,000 (approximately), with a £320,000 budget. The current budget is therefore over subscribed by £187,000.
- 5.3 The LAG reviewed and discussed each project and made a recommendation for each.
- 5.4 Discussion took place on the information presented to the LAG, PAC recommendations and the LAG's process for delegating funds. The LAG will discuss and assess projects based on the information provided like, for example, the PAC recommendations and funds available.
- 5.5 Project RCCF002 Installation of Solar Panels and Battery at Finzean Hall

Moira Beverley reported back to the LAG. The project will take place at Finzean Hall and look to install solar panels, battery and insulation. The grant requested is £11,000 with match funding of £3,000 and total project costs of £14,000. The building warrant is currently outstanding.

#### 5.21 RCCF012 Hydrogen Ready Boiler Axis Centre

The project will take place at the Axis Centre in Newmachar and will look to replace the natural gas boiler with a new hydrogen ready boiler. The project would look to reduce carbon emissions and assist with moving towards net zero. The grant requested is £11,034 with match funding of £1,226 and total project costs of £12,260.

The LAG supported the idea of future proofing but felt that the project costs may not be the most efficient use of funds, at this point in time, due to a lack of evidence on the expected arrival of hydrogen to the area.

# 5.24 RCCF022 Fraserburgh Cricket Club Batting Bays Project
