Where the Legal Basis for processing is either Performance of a Contract or Legal Obligation, please note the following consequences of failure to provide the information:

The Council has a statutory duty under the Scots common law of 'Bona Vacantia' to report to the Crown any ownerless objects (with the exception of modern objects, e.g. Victorian coins and machinery fragments) found by chance or through activities such as metal-detecting, field-walking, or archaeological excavation. Such objects may be claimed as treasure trove..

Furthermore if the artefact/s found by chance are significant then details may be passed on to Historic Environment Scotland to enact a call-off contract to record the findspot and remove the artefacts

Failure to process your data and report the find would breach this duty. It could also mean that artifacts of historical interest and importance are lost as well as the objects not being claimed as treasure trove.

For human remains the Council has a statutory duty under Scots common law whereby all human remains have 'the right of sepulchre' to provide information to Police Scotland.

Furthermore if the remains have been found by chance then details may be passed on to Historic Environment Scotland to enact a call-off contract to record and remove the remains.

Failure to process your information and provide it to the statutory authorities could result in a breach of common law duty as well as historical remains being lost to the nation

For Scheduled Monuments the Council has a duty under the Ancient Monuments and Archaeological Areas Act 1979 to help protect such structures and is required to notify and assist Historic Environment Scotland and Police Scotland to take any appropriate enforcement action or prosecutions against any unauthorised works or damage to the Scheduled Monuments.

Failure to process your information and to provide it to the appropriate authorities could result in the destruction of historic sites and Scheduled Monuments and the failure to prosecute those people responsible for this unauthorised work or damage.

- Treasure Trove who are responsible for all ownerless objects in Scotland (with the exception of modern objects).
- Police Scotland who are responsible for all discoveries of human remains.
- Police Scotland should the asset that has been damaged be owned by the Council.
- Historic Environment Scotland who are responsible for the designating of Scheduled Monuments, and the monitoring and enforcement against any unauthorised works or damage to a Scheduled Monument.
- Historic Environment Scotland who are responsible for archaeological call-off contracts dealing with unexpected human remains or unexpected significant artefact discoveries outwith the Planning system
